## Definition

"Price" shall mean the cost of the Goods as agreed between the Seller and the Buyer subject to clause 4 of this contract.

#### Acceptance 2. 2.1

- Any instructions received by the Seller from the Buyer for the supply of Gods and/or the Buyer's acceptance of Gods supplied by the Seller shall constitute acceptance of the terms and conditions contained herein. Where more than one Buyer has entered into this agreement, the Buyer's shall be jointly and severally liable for all payments of the Price. 2.2

## Delivery Of Goods / Services

- Delivery of the Goods shall be made to the Buyer's address. The Buyer shall 51 make all arrangements necessary to take delivery of the Goods whenever they are tendered for delivery, or delivery of the Goods shall be made to the Buyer at the Seller's address.

- If any of the Goods are damaged or destroyed prior to property in them passing to the Buyer, the Seller is entitled, without prejudice to any of its other rights or remedies under these Terms and Conditions of Trade (including the right to receive payment of the balance of the Price for the Goods), to receive all insurance proceeds payable for the Goods. This applies whether or not the Price has become payable under the Contract. The production of these terms and conditions by the Seller is sufficient evidence of the Seller's rights to receive the insurance proceeds without the need for any person dealing with the Seller to make further enquiries.

## **Buyer's Disclaimer**

Buyer's Disclaimer The Buyer hereby disclaims any right to rescind, or cancel the contract or to sue for damages or to claim restitution arising out of any misrepresentation made to him by any servant or agent of the Seller and the Buyer acknowledges that he buys the Goods relying solely upon his own skill and judgement and that the Seller shall not be bound by nor responsible for any term, condition, representation or warranty other than the warranty given by the Manufacturer which warranty shall be personal to the Buyer and shall not be transferable to any subsequent Buyer.
